Highlights

- 2. On November 9, Councilwoman Rivera and CB 6 are co-hosting a rat academy workshop by the Department of Health and Mental Hygiene. Join us to learn about pest control and prevention. On September 24, Councilwoman Rivera chaired a hearing in New York City Council's Committee on Hospitals about intern and resident physicians' health and wellness, following an alarming trend of residents dying by suicide. We heard directly from impacted residents about the root cause of the issue and why we need to demand much needed change. On September 30, Councilwoman Rivera chaired a hearing in the New York City Council's Committee on Hospitals jointly with the Committee on Health about vaccine hesitancy and equity in New York City.
