**Manhattan Community Board 6 Report, April 2023**

1. In regard to former President Trump’s indictment earlier this month, Congressman Nadler issued the following statement:

- “On its face, this indictment seems methodical and well-reasoned. Mr. Trump will, of course, have every opportunity to defend himself in court like every other defendant in the New York judicial system. In our justice system, defendants are presumed innocent until proven guilty. And this matter will play out in the New York criminal justice system, no matter how MAGA Republicans try to obstruct the process. In a desperate attempt to protect Mr. Trump, the most extreme House Republicans are already trying to bully the law enforcement officers involved. I do not know how this case will be decided, but I do know that DA Bragg will not be deterred or intimidated by the political stunts Jim Jordan and Kevin McCarthy throw at him.”

2. Congressman Nadler also had a busy month in Washington D.C.:

- Earlier in the month, Congressman Nadler organized a bipartisan meeting with Governor Hochul and the New York delegation to learn how the state was managing the bank failures and its effect on New Yorkers’ to bank with confidence. He also applauded the Biden administration for moving swiftly to safeguard depositors while ensuring American taxpayers won’t bear any of the burdens of this crisis.
- Congressman Nadler along with other members of the Judiciary Committee wrote a letter to Kevin McCarthy and Jim Jordan urging them to bring the Assault Weapons Ban to the floor for a vote. In the last Congress, Congressman Nadler shepherded the Assault Weapons Ban from the Judiciary Committee to passage on the House floor with bipartisan support. Tragic mass shootings, like the one we saw in Nashville, are sober reminders that Congress can and must do more to keep our children safe in schools.
- Lastly as Republicans push legislation that threatens clean air & safe drinking water and attack clean energy, such as HR1, Democrats are delivering support for innovative green energy as seen by the EPA’s announcement of \$3M awarded to New York State to unlock new ways to address climate pollution and put the state on a path to achieving a zero-emission electricity sector by 2040. This funding came from the Inflation Reduction Act passed last year.
